Sustainability is a key focus across our hospitality assets, with many properties achieving notable certifications and implementing impactful environmental initiatives. The hospitality team continually seeks opportunities to enhance energy efficiency, integrate eco-friendly materials, and optimize water usage.

Current Sustainability Initiatives

Across our hospitality properties, we implement various initiatives to reduce environmental impact and promote long-term efficiency. Energy use reduction is a priority, with strategies including energy-efficient lighting, optimized HVAC systems, and smart building controls. We also emphasize future-proofing by integrating infrastructure for renewable energy sources and designing adaptable spaces that can evolve with technological advancements.

Material selection plays a critical role in sustainability efforts. Our hospitality projects prioritize sustainably sourced, recycled, and low-impact materials to minimize environmental footprint. Additionally, water conservation strategies include the use of low-flow fixtures, water-efficient landscaping, and smart irrigation systems to reduce overall consumption.

Waste management is another key point for sustainable assets, with comprehensive recycling and composting programs integrated across properties. By engaging staff and guests in sustainability efforts, we foster a culture of environmental responsibility within our hospitality portfolio.

Future Sustainability Efforts

Moving forward, sustainability will remain a central focus in new hospitality developments and acquisitions. We will continue identifying opportunities to enhance energy efficiency, integrate renewable energy sources, utilize sustainable materials, and improve water conservation. Additionally, we plan to further refine our waste reduction strategies by increasing on-site composting and expanding guest engagement initiatives related to sustainability.





Multifemily

Our multifamily properties are designed with sustainability in mind, integrating cutting-edge environmental strategies to reduce energy consumption, enhance tenant well-being and prepare our buildings for the future.

Current Sustainability Initiatives

Energy Use

- We utilize Energy Star-certified appliances and install high-efficiency HVAC systems to minimize energy demand.
- Building design prioritizes natural lighting and superior insulation, reducing the need for artificial lighting and excessive heating/cooling.
- Energy consumption is tracked through tenant usage reports, with data compared against industry benchmarks to measure efficiency gains.

Future-Proofing

- To accommodate emerging technologies, properties are built with excess conduit capacity for low-voltage systems and smart building upgrades.
- EV charging infrastructure is incorporated into new developments, ensuring properties remain relevant as electric vehicle adoption grows.
- Adaptable design principles are applied to create flexible living spaces that can evolve with tenant needs.

Materials and Waste Management

- We prioritize the use of sustainably sourced and recycled materials, carefully tracking material sourcing to promote responsible construction.
- Tenant recycling programs and construction waste diversion initiatives help reduce landfill impact and promote responsible disposal practices.

Water Efficiency

- Low-flow fixtures and faucets are installed to minimize water waste.
- Landscaping incorporates hydrazones and drought-resistant plants, reducing irrigation needs and ensuring long-term water conservation.
- Sub-metering enables precise tracking of water usage, allowing for better management and efficiency improvements.



Current Sustainability Initiatives

Energy Use

- Skylights enable the use of daylighting strategies, reducing electricity dependence.
- Occupancy sensors ensure lighting efficiency by automatically adjusting based on usage.
- Wind power generation is being explored at select locations.
- Smart building controls optimize energy consumption across heating, cooling, and lighting systems.

Future-Proofing

- Properties are designed with solar-ready roofs, allowing for seamless solar panel installation.
- Conduits for future UV technology ensure readiness for upcoming energy-efficient systems.

Materials and Waste Management

- Reduced irrigation landscaping is implemented to minimize water use.
- Comprehensive recycling and composting programs support responsible waste disposal across both residential and retail spaces.
- Construction sites follow waste reduction guidelines, diverting materials for reuse where possible.

Smart building technology and infrastructure improvements will further optimize resource use and environmental impact reduction.













Master-Pannec Communities

Sustainability is at the heart of our master-planned communities, where we integrate environmentally responsible strategies to balance ecological preservation with modern development. Our sustainability strategy focuses on reducing waste, increasing energy efficiency, and integrating green building initiatives into commercial and residential developments at Baseline in **Broomfield and Centerra in Loveland.**

Key Achievements

- Centerra features 700 acres of parks and open space, with over 10 miles of sustainable, scenic trails.
- Centerra's landscaping uses regionally appropriate, native plants adapted to Colorado's climate and altitude. This approach reduces water usage and supports local biodiversity.
- Centerra was designated the state's first sustainable landscape community by the Associated Landscape Contractors of Colorado.
- Baseline is the world's first designated Pollinator District communities designed to conserve and improve habitat for pollinators in all aspects of development and operations.
- Baseline features 62 acres of park, trails and walkways.
- At Baseline, McWhinney is part of the Butterfly Pavilion's BEE Sustainable Partners Program, engaging our team in hands-on pollinator habitat restoration and invasive species removal across Colorado.

Partnership with High Plains Environmental Center (HPEC)

McWhinney's long-standing collaboration with HPEC at Centerra enhances biodiversity and promotes environmental education through initiatives such as:

- Native plant nursery development, plant sales and education to support wildlife-friendly landscaping and pollinator habitats.
- Guided nature walks focused on local ecology and conservation.
- Bird banding events to study and protect native species.
- Year-round classes and community workshops on sustainable landscaping and habitat preservation.
- Seasonal community events such as Earth Day cleanups and family-friendly celebrations.
- Water-wise landscaping to reduce irrigation needs.
- Smart infrastructure investment, including sustainable roadway test plots and eco-friendly landscape construction across Colorado.
- Contributions to Conservation International for environmental preservation.

Future Sustainability Efforts

We remain committed to advancing energy-efficient building design, promoting non-motorized transportation connectivity, and reducing reliance on natural gas. With continued investment in sustainable infrastructure, we aim to create communities that thrive for generations while preserving environmental integrity.
